## STUDENT RESPONSIBILITIES

<p><b>Policies and procedures</b></p>	<p><b>Students are expected to:</b></p> <ul style="list-style-type: none"> <li>• inform themselves of, and follow DTS policies as documented in the Student Handbook</li> <li>• respond to DTS communications promptly</li> <li>• advise DTS within 7 days of any change of contact details including current residential address, mobile number, email address and who to contact in the event of an emergency.</li> </ul>
<p><b>Learning and assessment</b></p>	<p><b>Students are expected to:</b></p> <ul style="list-style-type: none"> <li>• attend scheduled classes</li> <li>• actively participate in learning</li> <li>• complete all homework given</li> <li>• complete and submit all assessments on time</li> <li>• refrain from plagiarism, cheating and collusion</li> <li>• pay all fees due</li> <li>• ask for support if needed.</li> </ul>
<p><b>Classroom conduct</b></p>	<p><b>Students are expected to:</b></p> <ul style="list-style-type: none"> <li>• arrive on time for their class</li> <li>• be prepared for class</li> <li>• dress appropriately</li> <li>• only use handheld devices in class when they are relevant to the activity</li> <li>• communicate in English.</li> </ul>
<p><b>Respect and ethics</b></p>	<p><b>Students are expected to:</b></p> <ul style="list-style-type: none"> <li>• respect others' values and beliefs</li> <li>• interact with others in a collaborative, professional manner</li> <li>• use DTS resources for the purpose for which they are intended</li> <li>• refrain from harassment and discrimination of any kind</li> <li>• resolve any conflicts calmly</li> <li>• respect DTS and other people's property.</li> </ul>

## STUDENT RIGHTS

<p><b>Policies and procedures</b></p>	<p><b>Students can expect to:</b></p> <ul style="list-style-type: none"> <li>• be informed of DTS policies and associated procedures</li> <li>• receive regular and relevant communications</li> <li>• learn in a safe environment</li> <li>• have their personal details kept confidential and secure</li> <li>• access the information that DTS holds about them</li> <li>• have the opportunity to provide feedback on services received.</li> </ul>
<p><b>Learning and assessment</b></p>	<p><b>Students can expect to:</b></p> <ul style="list-style-type: none"> <li>• be provided with high quality training, assessment and support services</li> <li>• receive the support they need</li> <li>• have their assessments marked and returned within 10 working days of submission</li> <li>• receive feedback on assessments where the result is not satisfactory.</li> </ul>
<p><b>Classroom conduct</b></p>	<p><b>Students can expect their trainer and assessor to:</b></p> <ul style="list-style-type: none"> <li>• be on time for classes</li> <li>• be prepared for class</li> <li>• be knowledgeable and engaging</li> <li>• dress appropriately</li> <li>• only use handheld devices in class when they are relevant to the activity</li> <li>• communicate in English.</li> </ul>
